

# FIREFIGHTER PARAMEDIC

Crooked River Ranch Fire & Rescue (CRRF&R) is seeking applicants for the position of Firefighter/Paramedic. The goal for this recruitment is to immediately hire one qualified Firefighter/Paramedic to work a 48/96 shift schedule and establish a hiring list for future positions. Candidates who are licensed Paramedics but do not have preferred fire certifications are encouraged to apply. The training to obtain preferred qualifications listed below will be provided by the District and must be completed during the first 6 months of the probationary period.

# **About the District**

Crooked River Ranch Fire & Rescue is a combination fire district that provides fire, rescue, and emergency medical services to a 19.8 square mile area of rural residential, commercial, and recreational lands in southern Jefferson County. Our career and volunteer personnel respond to an average of 600 calls annually. 78% of our annual call volume is medical with the remaining 22% being fire related. A unique factor within our district is the deep river canyons. To respond to emergencies in these areas the District has a Technical Rope Rescue Team.

The community of Crooked River Ranch is the largest private subdivision in the state of Oregon with a population of approximately 5,500 people. It is located between the Deschutes and Crooked River canyons just south of Lake Billy Chinook. Amenities in the community include a golf course, swimming pool, tennis courts, restaurants, disc golf course, hiking trails, and other outdoor recreational opportunities.
